12. NEW BUSINESS

Commissioner Curtis explained that he had received an email from the National Association of Counties highlighting that Yakima County qualifies for about \$80,000 in funding under the Energy Efficiency & Conservation Block Grant Program from the Department of Energy. In order to receive these funds, the County will need to complete a non-binding pre-award information sheet by end-of-day Friday, and Commissioner Curtis asked if the Board would be amenable to him working with staff toward that end. Commissioner Linde agreed. Commissioner Curtis also noted that Human Services Director Esther Magasis explained some of the potential allowable uses for this funding to him.

Commissioner Linde commented on the recent news that the State Legislature opted not to fix the state's drug possession legislation this year, and wondered what Governor Inslee might decide to do with the funding set aside for diversion programs. He noted that local counties may opt to enact ordinances in lieu of State legislation, and that the Washington State Association of Counties is working with the Washington Association of Prosecuting Attorneys to find out more information. In response to Commissioner Curtis' question, Commissioner Linde confirmed that this would likely be a topic of discussion at the next Law & Justice meeting, followed by an update at a future BOCC meeting.
