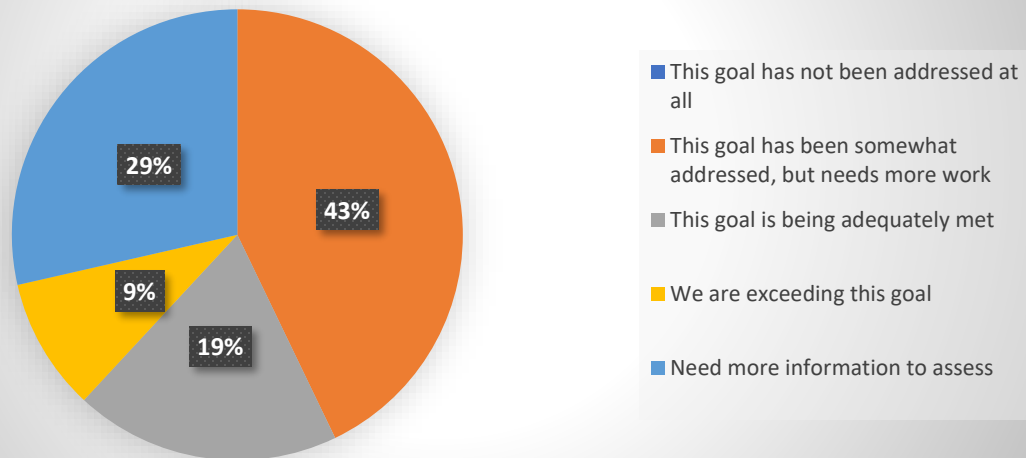

- Which goals (and responsible parties) need to be updated or otherwise changed?

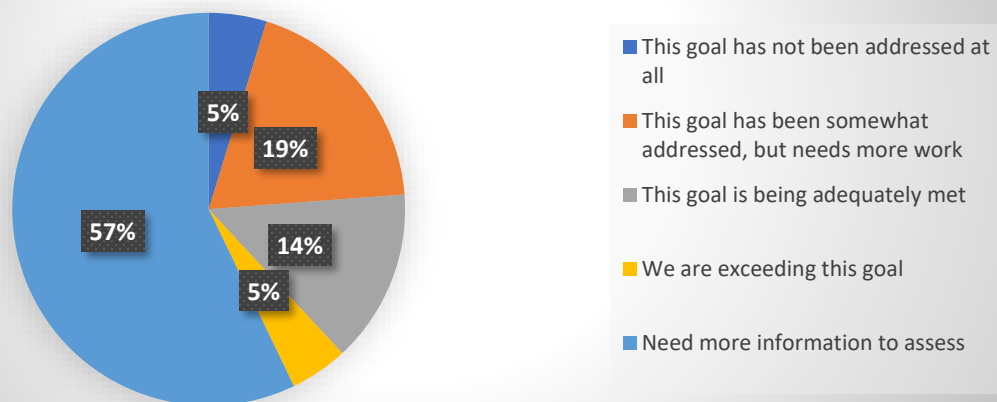
## Goal 1: Utilize a Coordinated Entry, Assessment, and Referral System

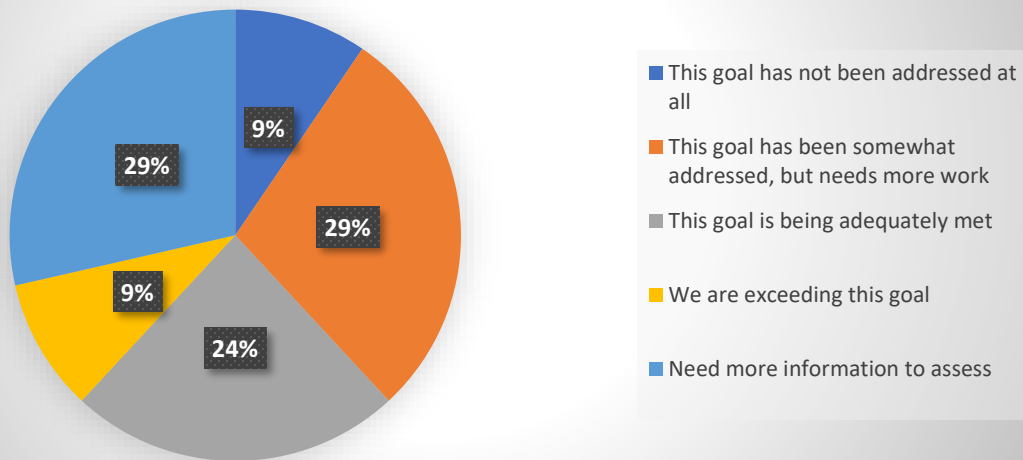

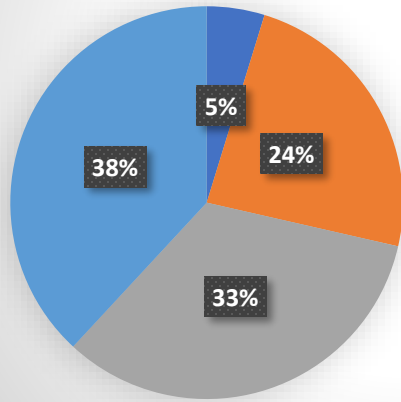

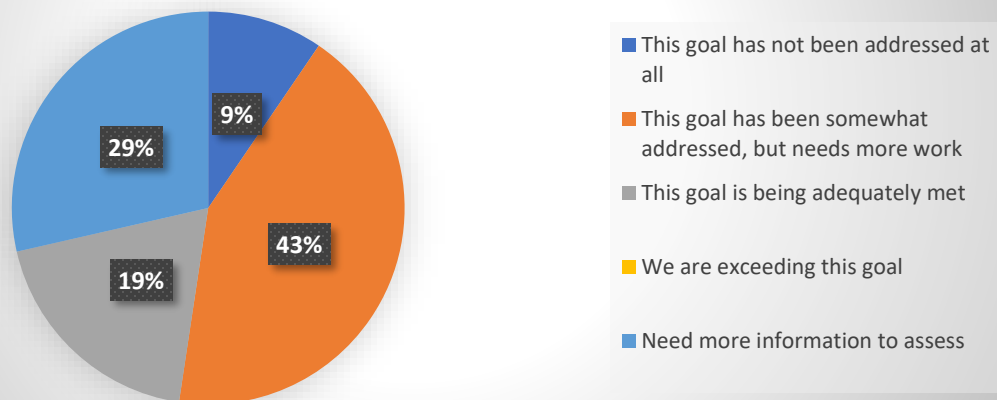

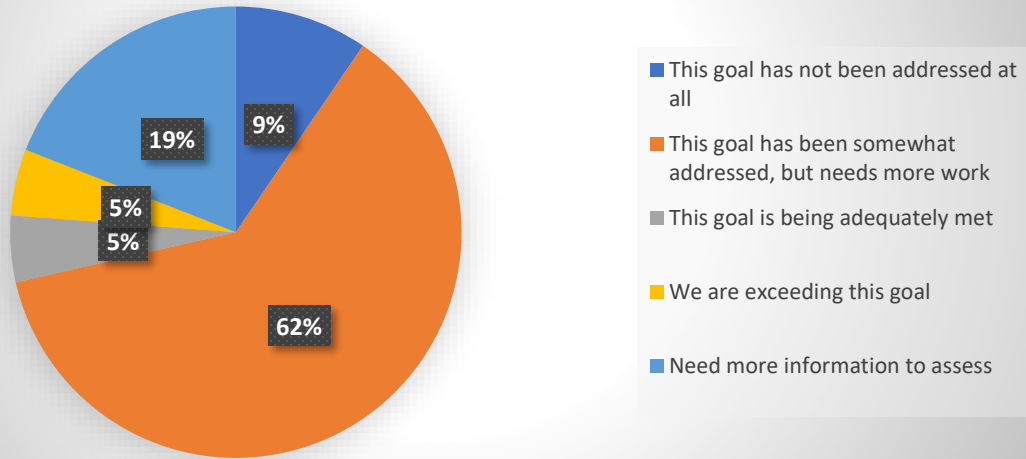
### Goal 9: Better serve youth homelessness
