6. **BOARD BUSINESS:** Andre Fresco, Yakima Health District (YHD) Executive Director

- a. **Local University Partnerships**

Strategic Goal: *Increased Community Partnerships*; **Board Input:** *Board Awareness*

The Health District will focus on building stronger partnerships with local universities by becoming more involved with the Yakima Valley Interprofessional Practice and Education Collaborative (YVIPEC). This is a collaboration between local universities to better educate and train the students on the community they are serving. Lilian Bravo and Andre Fresco met with leaders from Heritage University and Pacific Northwest University specifically to work on planning community projects, such as the gun safety event, similar to the one that was recently conducted with Seattle Children's, and eventually make them an ongoing event. Money from the enhanced budget is currently being considered to fund these initiatives.

- b. **Accela Upgrade**

Strategic Goal: *Improve Efficiency & Effectiveness*; **Board Input:** *Board Awareness*.

The Health District will upgrade to the newest Accela version, which is the system that is used by our Environmental Health department for permit tracking and billing. The upgrade will help staff provide better service to the public that require food permits, septic inspections, well inspections, and all other services provided by our Environmental Health specialists. The Health District is working with our technology service colleagues at the County to determine the upgrade cost.

June 2019 Budget Summary

We had a gain in excess revenue of approximately \$5K for the month of June, bringing our year-to-date excess revenue to \$239K.

- Annual budgeted revenues and expenditures are \$6.5M and \$6.6M, respectively.
- Year-to-date budgeted revenue and expenditures are \$3.2M and \$3.3M, respectively.

The Federal Single Audit is complete, went well, and expenses came in slightly under budget. Foundational Public Health Service continue to accrue. Federal revenue is more than expected mainly due to BCCHP and the Medical Admin programs. The increase in the Fees and Permits is mostly due to On-site Inspections and Food Permits.

Policies

Air Quality

The Health District put out a news release on air quality and what the public can do to protect themselves when air quality is poor. Temperatures are actively being monitored for possible heat advisories.

Measles

There have been 13 confirmed cases of Measles that were monitored after the state-wide outbreak after exposure from the SeaTac Airport. One of those cases was identified this month, so there is a month-long monitoring period before that case can be closed. Yakima has not been impacted by the Measles outbreak.

Hepatitis A

There is officially a Hepatitis A outbreak throughout the state and the nation. After the Yakima County Jail exposure, one successful incubation period has passed. The Health District's efforts were successful in responding to the Yakima County Jail exposure.

11. DISEASE CONTROL: Melissa Sixberry

Mumps

There were two possible cases of Mumps reported. Both cases came in close contact with one another and had people visiting from out of town.

Needle Exchange Program

The Health District conducted 52 surveys completed from the Needle Exchange program. The surveys included drug of choice, if they have insurance, are they homeless, and what zip code they stayed in the night before. This information will be given to the epidemiologist to gather information.

Wildfire Smoke

A pamphlet was created for wildfire smoke safety and lists available resources. This pamphlet will be handed out at public events. Nathan Johnson, our emergency response coordinator, has worked closely with our Environmental Health team to notify different committees, media outlets, and community groups about wildfire smoke and air quality. N95 masks are available for the public at our front desk. Wildfire smoke and air quality safety information is also being shared with the Health District staff.
