Update on Astria Regional Medical Center Closure

As of now, Astria Regional Medical Hospital remains closed. There is a state-wide discussion if Yakima County will have another hospital open, and how physicians in Yakima are at capacity. Clinics, physicians, and partners are working diligently to serve the public’s needs but do feel the impact of the hospital closure. Updates on what the future looks like regarding the hospital closure and potentially having another hospital open in Yakima County, will continue to be provided.

YHD Preparation for COVID-19 (Coronavirus)

The Yakima Health District staff has prepared their emergency response plan in the event there are positive cases of coronavirus in our county. With the support of the Center for Disease Control and the State Department of Health, the Yakima Health District has been actively working with partners and medical practitioners to prepare for the impact COVID-19 may have on the community of Yakima, and how to support our local hospital that is quickly reaching maximum capacity.

7. **FINANCIAL REPORT:** Chase Porter

January 2020 Budget Summary

We had a loss in excess revenue of approximately \$14K for the month of January.

January 2020 Revenue and Expenditures

- Annual budgeted revenues and expenditures are \$6.4M and \$6.8M, respectively.
- Year-to-date budgeted revenue and expenditures are \$536K and \$569K, respectively.
- Year-to-date actual revenue and expenditures are \$475K and \$490K, respectively.

Program Updates

Foundational Public Health (FPHS) revenue typically has a deficit at the beginning of the year, as they give YHD the funds in increments throughout the year based on a fiscal calendar. In 2020 the total FPHS funds will be received in the calendar year thus the deficit is eliminated.

Fees and Permits are down, which is expected this time of the year. There is an \$18K loss in Investment Income. Medical/Administration billing brought in additional funding of \$20K. Department of Health will fund the Yakima Health District an additional \$10K to use towards the Hepatitis A outbreak. Developmental Disabilities broke even for the month.

Coronavirus

Currently there are no positive cases in Yakima or an unexplained spread in the United States. There are zero domestic deaths. Communication to the public and to the media about how to avoid spread will continue to be published. Best practices recommended to protect yourself are good handwashing skills, cover your cough, and stay away from people who are ill. Yakima Health District staff are in constant communication with the Center for Disease Control and the State Department of Health regarding any COVID-19 updates and guidance.

Influenza

There have been 29 million people infected in the United States this flu season and 16,000 deaths. Flu vaccines are still available.

Hepatitis A

248 cases of hepatitis A have been identified in Washington State during this outbreak, and 5 deaths. A total of 15 counties in Washington State have been affected by this outbreak.

12. DISEASE CONTROL: Melissa Sixberry

Hepatitis A

There are currently 40 confirmed cases of hepatitis A in Yakima County, which are directly related to our homeless/illicit drug user population, with the exception of two cases. One death related to hepatitis A has been identified in Yakima County. Yakima Health District staff continues to provide clear communication to physicians, hospitals, and homeless shelters about hepatitis A prevention and education.

Coronavirus

Certain airports in the United States have identified incoming flights from China and screening those individuals. For those who are symptomatic, they are monitored by the State Department of Health and then deferred to the local health jurisdiction. Yakima Health District will monitor any potential exposures or cases that are identified in the county. YHD staff is working with DOH and with our Local Emergency Response Coordinator Nathan Johnson to be informed of updates and distribute clear, direct communications with partners, first responders, and physicians in Yakima County. The Yakima Health District has committed to purchasing N95 masks to give to first responders and the local hospital.

Influenza

Two deaths in Yakima County have been in connection to influenza. Yakima Health District staff continue to be in communication with stakeholders, medical practices, first responders, and long-term care facilities about influenza.

New Environmental Health Specialist

The Environmental Health team is now back to being fully staff with Marisol Oviedo being hired as the new Environmental Health Specialist. Her training will begin soon.

Cow Mortality

Both sites conducting the composition of the cow compost piles is nearly complete. Close monitoring of the temperatures and avoiding of possible contamination of water nearby has been a priority of the Environmental Health team.

Heritage Connectivity Trail

The Yakima Health District continues to partner with the Yakama Nation on the grant provided by the Department of Natural Resources, to add a trail system connecting from the City of Union Gap to the lower valley. The trail will be called the Heritage Connectivity Trail and it is about 150 miles of trail systems that will have educational material along the trails about the history of Yakima and the Yakama Nation. This is inspired by the high rates of deaths and traffic accidents along Highway 97, between Union Gap and Satus Pass. The Yakima Health District will participate by providing guidance on how to develop outreach and education on increasing physical activity but also highlight the need for these recreational trails to decrease traffic accidents and fatalities.
