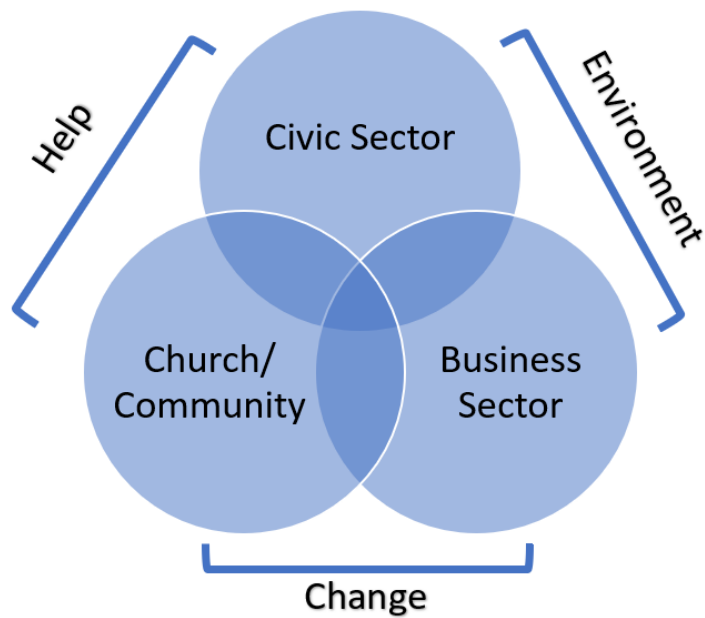

      - Establishing guidelines for: emergency shelters, short term housing needs, temporary encampments, supportive housing for chronically homeless persons, and long-term housing
    - Identified at January YHC General Membership meeting:
      - Public education on services funded and provided
      - Collecting public feedback and concerns
    - Other priorities as identified in the charter:
      - Data collection and review
      - Youth services
      - Affordable housing
      - Homeless services for special needs populations
      - Emergency shelter
    - Identified at February Executive Committee meeting:
      - Inviting staff from Commerce to present data profiles as part of public education efforts
      - Increased partnership with diverse stakeholders in the community (i.e. Chamber of Commerce)

### 3. COVID-19 RESOURCES FOR HOMELESS SERVICE PROVIDERS

- Increasing sanitation and social distancing is important at this time, recommendations are to maintain **6 feet of space** between individuals – including beds. This presents difficulties with space.
- How are providers responding to COVID-19?

- Funds are being made available from the State for COVID-19 response. Once an agreement has been signed to accept the funds, Yakima County will coordinate with City of Yakima and the Health District to develop a spending plan (per the funding requirements)
