OF YAKIMA COUNTY, WASHINGTON  
ORDINANCE NO. 5-2006

ORDINANCE ESTABLISHING TEMPORARILY THE MAXIMUM SPEED OF ALL VEHICLES TRAVELING UPON CERTAIN COUNTY ROADS OR PART OF SUCH ROADS, OUTSIDE INCORPORATED CITIES AND TOWNS, WITHIN YAKIMA COUNTY, WASHINGTON, DURING THE 2006 CONSTRUCTION PERIOD AND PROVIDING PENALTIES FOR ITS VIOLATION.

IT IS HEREBY ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF YAKIMA COUNTY, WASHINGTON, AS FOLLOWS:

SECTION 1. This Ordinance is enacted in exercise of the police powers of Yakima County and the State of Washington for the protection and preservation of the health and safety of the public.

SECTION 2. Yakima County is preparing to place a bituminous surface treatment on existing county roads. Speed of greater than 25 m.p.h. on the freshly treated roads is dangerous to the traveling public and is injurious to the freshly treated roads. The speed restrictions as listed in Section 3 will be temporary: they will be in force during the 2006 construction period.

SECTION 3. It shall be unlawful for the operator of any vehicle to operate the same upon any of the following county roads, outside the incorporated limits of cities and towns in Yakima County, Washington, at a speed in excess of twenty-five (25) miles per hour when so posted:

SECTION 4. All the maximum speed zones and limits as fixed in Section 3 above shall be posted with Speed Limit signs at the extremities thereof; and also, at such intermediate locations, as the County Engineer shall determine necessary .

SECTION 5. VIOLATION OF ANY PROVISIONS OF THIS ORDINANCE CONSTITUTES A TRAFFIC INFRACTION. A person found to have committed a traffic infraction hereunder shall be assessed a monetary penalty not exceeding TWO HUNDRED FIFTY DOLLARS (\$250.00) FOR EACH OFFENSE.

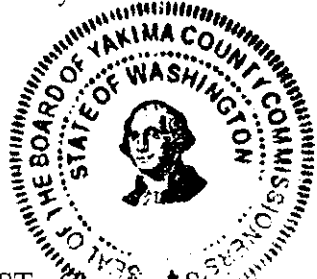

SECTION 7. This ordinance providing for the protection of the health and safety of the public, and its passage being emergent, shall be full force and effective from the date of its adoption and passage.
