Enclosed is the Final DNS for the proposed site-specific Comprehensive Plan map amendment and rezone for the emergency expansion to the Town of Naches Urban Growth Area. This is a non-project plan amendment and rezone. As the lead agency, Yakima County has determined that the proposed amendment will not require any additional mitigation measures under SEPA and will not have a significant adverse effect on the environment. Therefore, an Environmental Impact Statement (EIS) will not be required for this proposal.



FINAL DETERMINATION OF NON-SIGNIFICANCE

1. **Description of Proposal:** Yakima County must periodically review and, if needed, revise its comprehensive plan and development regulations to ensure that they comply with the Growth Management Act (GMA), as per the schedule provided in RCW 36.70A.130. This review also requires Yakima County to use the Washington State Office of Financial Management's population forecasts, the County's 20-year population allocations and a detailed land capacity analysis process. UGAs for all the cities and towns within Yakima County were previously updated in 2016 and 2017. The proposed amendment was initiated by the Town of Naches to add an approximate 40.17 acres to include adjacent parcels 171533-43005, 171404-12404, 171404-12403, 171404-12402, 171404-12401, 171403-42004, 171403-42005, and 171403-42023.
