Environmental Public Health is the focus on the relationships between people and the environment in which they live. Promoting human health and well being and foster healthy and safe communities

- Solid Waste
- Vector Control

Environmental Health at YHD

Staffing

- 1 Environmental Health Technician
- 7 Environmental Health Specialists
 - All EHS required to obtain Registered Sanitarian Certification within first 2 years
- Environmental Health Director

Budget

- Annual Operating Budget of 1.3 million dollars



Food Safety

Program Overview

- Annual Budget of \$465,000
- 3.5 Full Time Employees (FTEs)
- Three sub-programs:
 - Temporary Food Events
 - School Food Safety
 - Food Education (Food Worker Cards)



Food Safety

Program Purpose

- Prevention and investigation of foodborne illness outbreaks
- Ensure safe food preparation and handling practices

Our Work in Food Safety

- Plan review and licensing
- Food safety inspections, education, and compliance
- Temporary food event inspections
- Issuance of food worker cards and food education classes
- Foodborne illness outbreak response
- Emergency response

Water Recreation & Camps

Program Purpose

- Conduct routine inspections of annual and seasonal pools, spas and camps to ensure public health and safety

Our Work in Pools

- Annual operating budget of \$51,000
- 0.3 FTEs
- Plan reviews and permitting of pools and spas
- Conduct inspections of all pools and spas annually
- Provide education and corrective action items to operators
- Outbreak response



Water Recreation & Camps

Program Purpose

- Conduct routine inspections of annual and seasonal pools, spas and camps to ensure public health and safety

Our Work in Camps

- Annual operating budget of \$51,000
- 0.3 FTEs
- Plan reviews and permitting of camps
- Conduct inspections of all camps annually
- Provide education and corrective action items to operators as needed
- Outbreak response
