Subject: Public Comment Concerning: Disseminating Misinformation to the Public

To the Board and Hired Officials:

After reading the referenced article I continue to ask the question of, why do we have a health department; the information in this article is nothing but the misinformation being disseminated by our local officials that has no credence nor scientific value whatsoever.

Stephanie Badillo-Sanchez who is a spokesman for the health district stated in this article that the officials at the Yakima Health Department is using the guidelines this year to minimize the spread of the RSV and flu viruses on the Covid-19 guidelines. These guidelines are nothing but misinformation and if the professionals had and are doing their jobs in the health department you would know that!

The scientific information from well over 146 true scientific studies that have been peer reviewed have proven that wearing masks to prevent the spread of the Covid virus or any virus is nothing but a political statement and there is no scientific proof nor study that shows that any mask prevents the spread of any virus including airborne viruses. Comment:

As I was watching a previous Yakima Health Department Public recorded video meeting there was a discussion on the merits of harm reduction therapies including providing for Yakima residents life-saving reversal medications for opiate drug overdose, funding needle exchange programs, and providing medications and resources to treat addiction.

One particular Yakima County Commissioner and Yakima Health District board member piped up in opposition to these measures.

"You know, sometimes compassion can be enabling."

Those words have echoed in my head since I first heard them, and my disbelief and disgust is as fresh now as it was then. She said the quiet part loud, and perhaps revealed more than she intended.

Later in 2022 she posted a public "selfie" video along the Yakima Greenway as tons of debris including used needles and syringes was removed via helicopter. Wouldn't those cleanup workers have preferred this biohazardous waste to have been collected in appropriate receptacles? Wouldn't her constituents prefer fewer used needles in their public parks and paths? Isn't a Health District supposed to try to keep all its residents alive and healthy?

It's hard to imagine, but an elected public official with a six-figure annual salary paid for by the taxpayers publicly admitted that she believes some of her own constituents simply don't deserve a second chance.

That someone's daughter or son or father or mother fighting addiction isn't worthy enough to receive potentially life-saving treatment.

That some limbs aren't worth trying to prevent from becoming infected or necrotic.

That some mistakes deserve to be fatal, and that some lives just aren't worth saving even if you have the opportunity to prevent imminent death.

We really can't place too much blame on her and ought to give her some grace, because with all due respect exactly what business does an ex-mortgage banker have in making informed public health decisions or recommendations that affect the health and lives of others?

It is especially the people who struggle with addiction, people who suffer in poverty, and the people whose lives hang in the fine balance between life and death who deserve our utmost empathy, our compassion, and our grace.

It is my opinion that she should resign from her position within the Yakima Health District Board of Health, write an apology to be posted to the Health District website in both Spanish and English, and look deeply inward in reflection to discover exactly when and how she lost empathy for her fellow humans, if she possessed any to begin with.

Or, perhaps just as unrealistically, we could just change the message on the billboard when you come into town.
