Revised Code of Washington (RCW)

All permanent state laws

Enacted by the public or the Legislature and Governor

Public Health RCWs:
70.05, 70.46, 70.95

Washington Administrative Code (WAC)

Codify and regulate RCWs by subject

Created by State Agencies (e.g. Washington State Department of Health)

Public Health WACs:
173 and 246



Role of the Health Officer

- The duties of the health officer are primarily outlined in WAC 246-101-505
- Health officers are largely responsible for controlling communicable disease.
- This may include ordering isolation/quarantine and implementing emergency measures.
- Case investigations.
- Health districts are required to support health officers in fulfilling their role.





RCW 70.05.110; WAC 246-101

- Inform healthcare providers, hospitals, and labs about reporting requirements
- Review and take action on reported or suspected conditions
- Notify State Department of Health
- Authority to request exams for suspected cases

Specific Diseases


Sexually Transmitted Infections (STIs): RCW 70.24; WAC 246-100

- Investigate, examine, and treat STI cases
- Establish comprehensive networks for AIDS prevention and treatment
- Order HIV testing and provide court-ordered services

Tuberculosis Control:

RCW 70.28; RCW 70.30; WAC 246-170

- Receive and maintain records of active TB reports
- Provide treatment and case management



Birth and Death Certificates

Vital Statistics: RCW 70.58

Health districts must provide certified copies of birth and death certificates





NEW REQUIREMENTS FOR BIRTH AND DEATH CERTIFICATES/ NUEVOS REQUISITOS PARA LOS CERTIFICADOS DE NACIMIENTO Y DEFUNCIÓN

NEW REQUIREMENTS
As of January 1, 2021, Washington State passed a law requiring applicants provide proof documents showing the relationship to the requested birth certificate. Please visit www.doh.wa.gov for requirement information. Mail in applications will require proof of identity copies. You may place your order with our only approved online vendor, [VitalChek](#).

NUEVOS REQUISITOS
A partir del 1 de enero de 2021, el estado de Washington aprobó una ley que requiere que los solicitantes proporcionen documentos de prueba que demuestren la relación con el certificado de nacimiento solicitado. WHEN PURCHASING BIRTH CERTIFICATES/ AL COMPRAR CERTIFICADOS DE NACIMIENTO

- ID if expired more than 60 days it will be not be valid. / Identificación si caduca más de 60 días no será válida
- qualified relationship/ relación calificada
- The customer will need to provide a **marriage or domestic partnership** certificate that proves the customer is the spouse of the subject of the record/ El cliente deberá proporcionar un certificado de matrimonio o pareja de hecho que demuestre que el cliente es el cónyuge
- Foreign passport, driver's license, or ID card/Pasaporte, licencia de conducir o tarjeta de identificación extranjeros

WHEN PURCHASING DEATH CERTIFICATES/ AL COMPRAR CERTIFICADOS DE MUERTE

- ID if expired more than 60 days it will be not be valid. / Identificación si caduca más de 60 días no será válida
- **Death of a grandparent** provide their own birth certificate showing the linkage to their parent. / Muerte de un abuelo (a)proporcione su propio certificado de nacimiento que muestre la puebla con su padre o madre
- Copy of birth certificate/ Copia del acta de nacimiento
- The staff member of the **funeral home** is a qualified applicant for 12 months after the date of death and must submit a document identifying them as a staff member of that funeral home. / El miembro del personal de la funeraria es un solicitante calificado durante 12 meses después de la fecha de la muerte y debe presentar un documento que lo identifique como miembro del personal de esa funeraria.

Tobacco Prevention and Control

Access to Minors: RCW 70.155

- LHJs work in collaboration with DOH to enforce regulations related to youth access to tobacco and vapor products

Youth Tobacco and Vapor Products Prevention Account: RCW 70.155.120

- DOH provides funding for health districts to coordinate intervention strategies to prevent and reduce tobacco use by youth


Smoking in Public Places: RCW 70.160

- Health districts may adopt regulations to implement smoking provisions in public places
