FINAL DETERMINATION OF NON-SIGNIFICANCE (DNS)

1. **Description of Proposal:** On January 31, 2018, the Yakima County Public Services Department received an application for the 2018 Biennial Comprehensive Plan Map Amendment from Hordan Planning Services to amend the Yakima County Comprehensive Plan – **Horizon 2040** Future Land Use Map. The applicant proposes the Mineral Resource Overlay designation on 186 acres of an approximate 610-acre parcel while retaining the underlying current Remote/Extremely Limited Development Potential (R/ELDP) zone and Remote/Extremely Limited Development Potential (R/ELDP) land use designation.

4. **Location of Proposal:** The subject property is located north of Highway 410, approximately two miles west of Highway 410 and Highway 12 intersection, and approximately six miles west of the town of Naches. The subject property is identified as Assessor's Parcel 161527-11001.
5. **Lead Agency:** Yakima County Planning Division
6. **Determination:** The lead agency for this proposal has determined that it will not have a probable significant adverse impact on the environment and an Environmental Impact Statement (EIS) is not required under RCW 43.21C.030(2)(c). The lead agency has determined that the requirements for environmental analysis, protection, and mitigation measures have been adequately addressed in the development regulations and comprehensive plan adopted under chapter 36.70A RCW, and in other applicable local, state, or federal laws or rules, as provided by RCW 43.21C.240 and WAC 197-11-158. Our agency will not require any additional mitigation measures under SEPA for this non-project action at this time, however additional environmental review will be required at the project permit phase.

These determinations were made after a careful review of the completed environmental checklist, and other information on file with the lead agency.
