Review Systems Map Priorities	<p>Esther Magasis reviewed the Systems Maps and used the county website to outline how they work.</p> <p>Cassidy Leslie wondered about overlap. Esther says there is some overlap and asked how can we fill the gaps and needs?</p>
Resource Guide Development - Is a workgroup needed?	<p>Cassidy Leslie went over the Resource Guide and how the co-design of the process. How can we develop resources and make it easier to access them.</p> <p>Melissa discussed the gaps in services, after 5:00pm, weekends, etc. This was confirmed by others in the room, Trevor Downey and Dr. Zuckerman.</p> <p>All confirmed the need to increase referral process and contact lists for who to call when clients are in need of urgent not emergency services.</p>
