No Wrong Door Bill HB

Cassidy Leslie explained what brought the No Wrong Door Bill HB into place. It eliminated the requirement for clients to go through the process of completing an assessment prior to receiving treatment. Cassidy explained how it works for patients entering the Comprehensive Healthcare facility as a patient. There are multiple assessments being required of clients and there was discussion around what might be done to change the number/frequency of these assessments.
