Required recount – Commissioner of Public Lands

Primary – Yakima County, Washington – August 6, 2024

The required hand recount of 43,667 ballots for Commissioner of Public Lands did not result in any changes between the second (2nd) and third (3rd) place candidates who were within the statutory recount range.

There is one reported discrepancy that was discovered during the precinct consolidation phase of the recount.
