**Proposed Reduction of the County's Stock Restricted Area on the Yakama Reservation**

**NOTICE IS HEREBY GIVEN** that the Board of Yakima County Commissioners will hold an open record public hearing to receive testimony from the public concerning a proposal, as described below, to reduce the County's stock restricted area on the Yakama Reservation.

The hearing will be conducted in two sessions on **TUESDAY, OCTOBER 8, 2024**, as follows:

- **Session 1 – at 10:00 AM**, or as soon thereafter as possible, and
- **Session 2 – at 6:00 PM.**

Both sessions of the public hearing will be conducted in-person and virtually using the Zoom conferencing platform. The location of the in-person public hearing will be the Yakima County Courthouse Basement, Room 33B, 128 N. 2<sup>nd</sup> Street, Yakima, WA.
