Humane Services,

This memo aims to highlight the critical role of the Clerk's Office in ensuring that paperwork for the Therapeutic Courts is accurately docketed and processed. Proper documentation is essential for the effective functioning of the court and helpful for the success of its participants.

Therapeutic Courts are designed to provide an alternative to traditional court proceedings, focusing on rehabilitation rather than punishment. These courts address issues such as substance abuse and mental health challenges, offering participants the support they need to reintegrate into society. The Clerk's Office plays a vital role in this process by managing the documentation that are related to these proceedings.

Accurate and timely docketing ensures that cases are processed without unnecessary delays. This is crucial for maintaining the court's schedule and for the participant's progress.

Proper Documentation holds all parties accountable, including the court, participants and support services. It provides a clear record of actions taken and decisions made.

Accurate records promote transparency in the court's operations, fostering trust among participants and the community.

The Clerk's Office is responsible for receiving, reviewing and filing all paperwork related to Therapeutic Court Cases. We serve as a liaison between the court and participant, ensuring that all necessary information is communicated effectively.

The involvement of the Clerk's Office in the Therapeutic Court process is essential for partial success by ensuring accurate docketing and effective communication along with our partnership with Court Admin and the Therapeutic Court staff. The Clerk's Office supports the courts mission of rehabilitation and community reintegration.

- **What specific training does the Clerks Office receive to handle Therapeutic Court paperwork effectively?**
  - Training is conducted in a live court environment, allowing clerks to observe and participate in actual proceedings. There they receive real time feedback from supervisors and experience in-court clerks.
- **How can we measure the impact of accurate docketing on the outcomes for participants in the Therapeutic Court?**
  - We measure inaccuracy by specific reports that are ran in Odyssey. Inaccuracies can be caught by running reports by specific docketing codes, documents that are

not attached to an index and any restitution that may have been ordered in during the defendant's time in Therapeutic Court.


- **What additional Resources or Support Might enhance the Clerk's Office's ability to serve this court effectively?**


### Quarley Report
