Rod's House Outreach 2025 Contract Modification 1 (RH-Outreach-2025-MOD1)

Background Information:

Rod's House requested \$31,900 (per year) in the 2024-26 HHAP RFP for Outreach. Rod's House was awarded \$10,890. This modification increases their year 1 award by \$21,010 bringing the total year 1 award to the full requested \$31,900 and leaving year 2 unchanged. The additional funding is from one-year non-recurring funds granted by the State Department of Commerce.


