Background Information:

Yakima Neighborhood Health Services requested \$13,800 (per year) in the 2024-26 HHAP RFP for Coordinated Entry Young Adults. Yakima Neighborhood Health Services was awarded \$6,912. This modification increases their year 1 award by \$6,888 bringing the total year 1 award to the full requested \$13,800 and leaving year 2 unchanged. The additional funding is from one-year non-recurring funds granted by the State Department of Commerce.



