MEETING MINUTES
February 26, 2025**

1. Call to Order

The meeting was called to order by Board Chair Patricia Byers at 8:33 AM.

2. Executive session: To discuss with legal counsel matters relating to agency enforcement actions or potential litigation. [RCW 42.30.11\(1\)\(i\)](#). The Board of Health entered the executive session at 8:33 am. The Board of Health concluded the executive session at 9:03 am.

3. Introduction of Guests/Staff. Members from LatinX, a local community outreach organization, attended. Also in attendance was Evan Pierce, community member.

3. Review of Public Comments

Three public comments were made before the Board: one by community member Evan Pierce, another by Gabriella from the LatinX organization, and a third by an unidentified woman, also representing the LatinX organization.

4. Consent Agenda

The following items were adopted upon approval of the consent agenda:

- Approval of minutes from January 29, 2025, Yakima Health District Board of Health meeting.
- Payment of accounts payable and payroll for January 2025 totaling \$1,171,466.74.

Motion: to approve the consent agenda by Dr. Dave Atteberry and seconded by Edie Dibble.

The motion was approved with 9 in favor and 0 opposed.

4. YHD Spotlight: Advanced Food Safety by Shawn Magee, Environmental Health Director.

- Foodborne Illness Outbreaks: Discussed causes of foodborne illnesses, investigation costs, and best practices for promoting a safer food culture.
- Certified Food Protection Manager Class: YHD offers an affordable Food Protection Manager certification course for the public and local businesses, available in both English and Spanish.
- Community Outreach: YHD provides a variety of outreach initiatives to support community food safety education, including temporary food event workshops, in-person food handler training, and help desk services for food safety support.

5. Agency Updates

Executive Director: Andre Fresco

- State and Federal Administration Changes: The State Board of Health is undergoing leadership transitions, with an open position for the Secretary of Health to remain open until May. The State Department of Health continues to experience leadership and staffing changes, alongside budget reductions. Additionally, Federal health trend information sharing has decreased.
- Fire Season: Continued focus on planning for the upcoming wildfire season and potential power outages, ensuring readiness and response strategies.
- 2026 FIFA Fan Zone: Yakima County has been selected as an official fan zone for the 2026 FIFA World Cup, offering significant opportunities for community engagement and tourism.

Chief Operating Officer: Ryan Ibach

- YHD Remodel Project: The sealed bid process for contractor services began on February 25th, with a second advertisement published on March 5th. A pre-bid meeting will be held on March 6th, and the bidding period will close on April 4th at 2:00 PM.
- Emergency Preparedness: YHD's Local Emergency Response Coordinator and Public Information Officer participated in the Columbia Basin Generating exercise organized by the Yakima Valley Office of Emergency Management. Upcoming emergency response efforts will focus on the FIFA fan zone preparations and the five-year homeless housing strategic planning.

Financial Report: Chase Porter

- January Financials: Gain of \$43K.
- Budgeted Revenue: \$13.4M. Actual Revenue: \$1.2M.
- Budgeted Expenditure: \$15.7M. Actual Expenditure: \$979K.
- Financial Report: The actual gain in the Investment Income of \$306K was mainly due to 2024 year-end investment adjustments.
- FPHS Funding: The total funding for Foundational Public Health Services was allocated upfront, which may result in timing differences throughout the year. Due to state and federal budget reductions, there is uncertainty regarding potential future reductions in public health funding. However, no changes are anticipated for 2025.

Motion: to send a letter to Governor Bob Ferguson from the Board of Health, outlining the potential negative impact of the loss of federal funds on Yakima County.

Move to approve by Amanda McKinney and seconded by Alicia Stromme Tobin.

The motion was approved with 9 in favor and 0 opposed.

Amanda McKinney suggested Board Chair Patricia Byers write the letter.

Disease Control: Melissa Sixberry

- Upper Respiratory Illnesses: RSV and COVID-19 rates remain stable locally and nationally. However, Yakima County is experiencing a high number of influenza cases, with 9 flu related deaths reported this season in Yakima County.
- H5N1: No local cases or activity have been reported. Nationwide, 70 human cases have been identified, with one fatality.
- Yakima County has 11 confirmed tuberculosis cases, with five under the monitoring of the Yakima Health District and six under Indian Health Services' with YHD oversight.
- Measles Outbreak: Texas and New Mexico are facing a measles outbreak, primarily affecting unvaccinated individuals, 80% of whom are under the age of 18. No measles activity has been reported in Washington.
- Child Fatality Review: Key successes include the distribution of trigger lock boxes during well-child checks and ongoing collaboration with the Handle with Care project.
- Suicides: Concerns were raised about messaging to youth regarding suicide and mental health, particularly in involving parents in those conversations. YHD staff emphasized their role in supporting local partners, organizations, schools, and community members in providing culturally appropriate resources and education.

Environmental Health: Shawn Magee

- Accela Update: The permit management software Accela will undergo migration starting March 26th through April 1st, temporarily disabling several services. Community notifications regarding this transition have been issued.
- PFAS Testing: Five additional homes have been enrolled for PFAS testing around the DTG Landfill.
- Local On-Site Wastewater Ordinance: To align with updates in the Washington Administrative Code for on-site sewage systems, a new ordinance will need to be adopted by the Board of Health.

Public Health Partnership: Ryan Ibach

- EPA Grant: In collaboration with Dr. Consuelo Rodriguez, a well water safety curriculum has been finalized. This will enable Community Health Workers to conduct home visits for private well water users.
- Substance Use Prevention Campaigns: A parent-focused multimedia prevention campaign will begin hosting focus groups for parents, caregivers, and community members working with youth. The aim is to foster parent-teen conversations about drug use and overdoses. A second campaign will expand the “Escape the Escape” initiative, a youth-led effort to prevent substance use through peer-driven messaging. Several Board members emphasized the importance of ensuring that substance use prevention campaigns are supported by evidence-based data.

Community Programs: Gabriella Alvarez

- Transition Services: YHD Transition Specialist Daniel Bravo has organized the first collaborative meeting with the Developmental Disabilities Administration, Division of Vocational Rehabilitation, and several school districts, including Yakama Nation, to improve partnerships and communication.
- Accela Update: The front office team will continue to provide essential services and notify the public about the upcoming Accela migration period.

6: Unfinished Business: None.

7: New Business: Patricia Byers informed members of the public that they could meet with Edie Dibble after the meeting to address any questions and access mental health resources. She also encouraged the public to contact their legislators regarding any concerns they may have.

8. Adjournment

Move to adjourn by Dave Atteberry seconded by Amanda McKinney.

The motion was approved with 9 in favor and 0 opposed.

The meeting adjourned at 10:51 AM. The next Board of Health meeting is scheduled for March 26, 2025.

Yakima Health District Board of Health

Honorable Governor Ferguson,

The Board of Health governing the Yakima Health District (YHD) is seeking your assistance. Serving as Chair of the Board, I am regularly informed of the operations of YHD. They run a mean and lean operation! The level of accountability, work ethics, broad reach of services, specific health related programming, innovations, community partnerships, and successes is remarkable and to be commended. Especially in a geographically large, and second most impoverished county in the state.

We recently reviewed your release of a plan to save \$4 billion in the current budget shortfall. As tax paying individuals, we can appreciate your efforts. Yet as committed leaders to our communities, we are equally concerned about YHD's ability to provide the ongoing critical services that it offers. These include safety in food handling, environmental health, harm reduction in the area of substance abuse and related physical/medical help, developmental disability help and training, disease control, emergency management, and educational programs for parents and youth regarding substance use.

You identified two areas specifically in Public Health. One was the reduction of Foundational Public Health dollars by \$22 million dollars per year. We are concerned how, compared to metropolitan areas, that will affect our more impoverished rural areas in the need for public health services. The second area was a stark reminder that the Federal COVID dollars were one-time funds. Period. They are no more. However, that does not mean that federal funds are not available. We are asking that you consider how our state can pursue federal funding to continue with critical services in public health. Because as our Governor, it is incumbent upon you to facilitate bringing that funding into our state.

Thank you for bravely stepping into the leadership role you now occupy. We desire to hear from you on the critical issues we bring to your attention.

LOCAL ON-SITE WASTEWATER DISPOSAL ORDINANCE

PURPOSE: To adopt the on-site wastewater disposal regulations under a local on-site wastewater disposal ordinance.

WHEREAS, the Yakima Health District provides prevention, education, and disease control services to promote, protect, and enhance the health and safety of all people in Yakima County; and

WHEREAS, on-site wastewater rules and regulations are promulgated under the authority of Chapters 43.20, 70A.105, 70A.110, 70A.205, and 90.46 of the Revised Code of Washington (RCW), and Chapters 246-272A, 246-272C, and 246-274 of the Washington Administrative Code (WAC); and

WHEREAS, the Health Officer for the Yakima Health District shall enforce the public health statutes of the state pursuant to RCW 70.05.040 and 060; now therefore

BE IT HEREBY RESOLVED by the Yakima Health District Board of Health:

Section 1. Scope

This ordinance shall apply to all territory within the limits of Yakima County and the Yakima Health District.

Section 2. Authority

This ordinance is promulgated under the authority of Chapters 43.20, 70A.105, 70A.110, 70A.205, and 90.46 Revised Code of Washington (RCW) and Chapters 246-272A, 246-272C, and 246-274 Washington Administrative Code (WAC), to protect the public health, safety, environment, and welfare of the citizens of Yakima County.

Section 3. Purpose

This ordinance governs the on-site handling and disposal of wastewater within Yakima County, including permit issuance by adoption of WAC 246-272A, 246-272C, and 246-274.

Section 4. Administration

The Yakima Health District Health Officer shall administer the provisions of these regulations.

Section 5. Adoption of State On-Site Wastewater Disposal Rules

In accordance with the provisions of RCW 70A.205.100, the Yakima Health District Board of Health hereby adopts all sections of WAC 246-272A, 246-272C, 246-273, and 246-274 as written, except where modified and specified herein.

Section 6. Definitions

WAC 246-272, 246-272A-0010, 246-272C-0020, and 246-274-009 "Definitions" are hereby adopted by reference with the following additions:

- a. "Health District" means the Yakima Health District.
- b. "Health Officer" means the Health Officer of the Yakima Health District or his/her duly authorized representative.

Section 7. Development of Policies

The Health District may establish written policies and procedures to ensure uniform implementation of WAC 246-272A, 246-272C, 246-273, and 246-274 and to establish acceptable procedures and practices in the enforcement of the rules.

Section 8. Fees

Fees established for on-site wastewater disposal permitting and activities are established and updated by the Yakima Health District and adopted by the Yakima Health District Board of Health.

Section 9. Severability

If any section or provision of this regulation is adjudged to be invalid or unconstitutional, such adjudication shall not affect the validity of this regulation, or any section, provision or part thereof not adjudged invalid or unconstitutional.
