1. Call to Order

4. Consent Agenda

The following items were adopted upon approval of the consent agenda:

- Approval of minutes from February 26, 2025, Yakima Health District Board of Health meeting.
- Payment of accounts payable and payroll for February 2025 totaling \$1,085,028.15.

Motion: to approve the consent agenda by Dr. Dave Atteberry and seconded by Kyle Curtis. The motion was approved with 7 in favor and 0 opposed.
(*Katherine Saluskin was not present at the time of the vote*)

4. YHD Spotlight: Tracking Yakima County RSV and Influenza Data by Lilian Bravo, Director Public Health Partnerships.

- YHD works with local hospitals to track RSV and Influenza data every season.
- Information is presented in a report to hospitals on a weekly basis.
- YHD started utilizing Microsoft BI to make the data easier to digest by providers and the public.
- YHD provides timely updates during flu activity spikes, issues a media release for the season's first flu death, and disseminates social media posts on vaccine availability, prevention measures, and relevant updates.

5. Agency Updates

Executive Director: Andre Fresco

- State and Federal Funding: Given the uncertainty at the state and federal levels regarding funding, future budget reductions are anticipated; however, no changes are expected for this year. The State Department of Health is implementing significant budget cuts and staff layoffs to reduce expenses.
- YHD Remodel: The remodel project will move forward as the budget is strong and within limits, despite concerns over potential state and federal budget cuts. It is also more cost-effective than buying a new building. A Board member asked to consider the importance of having Wi-Fi and internet capabilities to remain a priority of the remodel process. Several Board members expressed their support for the remodel, citing its potential to improve patient privacy.

Chief Operating Officer: Ryan Ibach

- YHD Remodel Project: The sealed bid process for the YHD Remodel Project will conclude on April 4, 2025, with all submitted bids being opened on the same day.
- Union Negotiations: Collective bargaining negotiations will begin in June in preparation for the expiration of the current agreements at the end of the year.
- Opened Positions: The Yakima Health District is currently advertising for a Public Health Nurse position.
- Emergency Preparedness: YHD staff will attend the Pacific Power public forum on April 28th to prepare for potential wildfire-related power shutoffs. Additionally, the Local Emergency Response Coordinator will serve on the FIFA Public Health Committee, established by the State Department of Health and the Washington Emergency Management Division, and participate in the subcommittee planning the Yakima fan zone site for the 2026 FIFA World Cup.

Financial Report: Chase Porter

- February Financials: Monthly loss of \$227K for an annual loss of \$184K.
- Budgeted Revenue: \$2.2. Actual Revenue: \$1.7M.
- Budgeted Expenditure: \$2.6M. Actual Expenditure: \$1.9M.
- Financial Report: Foundational Public Health Services funding was provided upfront in 2024 for both 2024 and 2025, carrying over \$2M. Expenses for services in the BCCHP and Environmental Health programs are expected to increase as these programs continue to become busier. The Yakima Health District has experienced gains in the Investment Income program year-over-year, however a decrease is anticipated due to economic conditions.

Health Officer: Dr. Neil Barg

- Local hospitals are equipped to detect H5N1 through laboratory testing and can forward samples to the state lab for confirmation. Collaboration with the Yakama Nation, CDC, and local healthcare providers will support the dissemination of best practices to enhance care within the local medical community.
- Article from the Economist: Provides an analysis of the reasons behind the rising costs of medical care in hospitals, in comparison to other countries.
- Measles: Outbreaks continue in Texas and New Mexico, while Yakima County maintains the highest measles vaccination rate in Washington State, which is sufficient to prevent an outbreak. Areas with current outbreaks have vaccination rates below the 95% threshold needed for prevention. Nationally, the vaccination rate is 92%, which may contribute to the continuation of outbreaks.

Disease Control: Melissa Sixberry

- Measles: Two cases have been reported in Washington State: one in King County and a second, related case in Snohomish County.
- Tuberculosis: Indian Health Services is managing 9 cases, while YHD is overseeing 7 cases. Both organizations are collaborating to monitor and manage an outbreak in the Lower Valley.
- Influenza: Influenza rates remain elevated, with 12 local deaths reported. While influenza is not a reportable disease, deaths attributed to influenza are subject to mandatory reporting.

Environmental Health: Shawn Magee

- Environmental Health Services: YHD staff are busy with seasonal pool inspections, increased land development applications, temporary food events, and camp evaluations in preparation for wildfire season. Additionally, YHD continues to conduct sanitary surveys for Group A water systems on behalf of the State Department of Health.
- Certified Food Protection Manager Class: Testing events have commenced, with a 90% pass rate. The class is available in both Spanish and English.
- Onsite Solid Waste: Effective April 1, 2025, the updated Washington Administrative Code governing onsite sewage systems will take effect.
- Accela: The permit management system, Accela, will be offline from March 27th to April 1st for system upgrades. Multiple communications have been sent to the public to inform them of the migration period.

Public Health Partnership: Lilian Bravo

- Due to the loss of federal funding, several vaccine programs have been discontinued, including the State Department of Health's Care-A-Van, which successfully vaccinated over 700 individuals in Yakima County. Discussions are ongoing with the State Department of Health to explore alternative service models. Additionally, the kiosk at Fiesta Foods in Sunnyside, which provided flu and COVID-19 rapid test kits, will cease operations as of April 1, 2025.
- Substance Use Prevention: A partnership with Yakima Neighborhood Health Services will continue to distribute materials developed by youth involved in the creation of *Escape the Escape* through various multimedia channels.

Community Programs: Gabriella Alvarez

- Developmental Disabilities: To celebrate National Disability Awareness Month, YHD launched the *Feel-Good Friday* social media campaign, highlighting the achievements of developmentally disabled clients and their community integration. Jennifer, Program Manager at Elmview, joined the video series *Coffee with the Health District*, to share resources and guidance on employment for individuals with developmental disabilities.
- Front Office Team: The team has prepared for the Accela system shutdown and reopening, anticipating an increase in workload as a result.

6: Unfinished Business:

- a. Letter to Governor Bob Ferguson from the Board of Health, outlining the potential negative impact of the loss of federal funds for Yakima County: Patricia Byers.
The Board of Health reviewed proposed revisions to the letter addressed to Governor Bob Ferguson, highlighting the negative impact that reductions in federal funding would have on critical services.

Motion: to approve and sign the letter addressed to Governor Ferguson with the suggested revisions. Moved by Kyle Curtis and seconded by Luptia Carrillo.
The motion was approved with 7 in favor and 1 opposed.

7: New Business:

- a. **Propose Motion:** to approve the Local On-Site Wastewater Disposal Ordinance: Shawn Magee.

Due to changes in Washington Administrative Code 246-272A, minimum lot size requirements for septic system permitting will take effect on April 1, 2025, with additional requirements implemented on April 1, 2027. The Yakima Health District has introduced an ordinance aligning with these updates to enhance the efficiency of permitting services.

Motion: to approve the Local On-Site Wastewater Disposal Ordinance, moved by Kyle Curtis and seconded by Lupita Carrillo.

The motion was approved with 8 in favor and 0 opposed.

8. Adjournment

Motion: to adjourn by Dr. Dave Atteberry seconded by LaDon Linde.

The motion was approved with 8 in favor and 0 opposed.

The meeting adjourned at 10:26 AM. The next Board of Health meeting is scheduled for April 30, 2025.
