Rod's House Eviction Prevention 2025 Contract Modification 1 (RH-EP-2025-MOD1)

Background Information:

Rod's House was awarded \$55,000 for their Year 1 Eviction Prevention contract under the Homeless Housing and Assistance Program (HHAP), covering July 1, 2024, to June 30, 2025. This modification reduces Year 1 funding by \$31,265, adjusting the total to \$23,735. This adjustment is a voluntary reduction, offered by RH due to their expectation that funds would go unused by the end of the contract period. The returned funds will be redistributed to other active HHAP grantees, ensuring resources are directed where they are most needed to maximize the impact of funds used to addressing homelessness within the county. Year 2 funding remains unchanged, covering the period July 1, 2025, to June 30, 2026.

Describe Fiscal Impact:

\$0 – No net fiscal impact. The \$31,265 in returned funds will be reallocated to other active HHAP grantees based on their demonstrated needs, as outlined in their responses. Any unused funds will be returned to Commerce after June 30, 2025.





