Success: We were able to increase the number of new client inductions from 5 to 11 per week.

Barriers: Provider time requires an officer and so does the dosing with nurses. Only 1 officer available each day 8:30a-4:30p.

Program Changes: Clients placed on a taper then a 30 day wait instead of immediate discharge when diversion occurs.

3. Narrative summaries detailing program achievements/success, encountered barriers, & significant changes to the program.

Success: We were able to increase the number of new client inductions to 11 per week in addition to medication management services.

Barriers: Provider time requires an officer and so does the dosing with nurses. Only 1 officer available each day 8:30a-4:30p.

Program Changes: Clients placed on a taper then a 30 day wait instead of immediate discharge when diversion occurs. Dr. Zuckerman increased provider/client appt days at the jail from 1 to 3 days per week on Monday, Tuesday, & Friday from 2p-4p. Comprehensive Healthcare now has a MOUD kite system with YCDOC that clients contact for self-referral to the program.

3. Narrative summaries detailing program achievements/success, encountered barriers, & significant changes to the program.

Success: We are near the goal of 50 clients (ranging from 45-48).

Barriers: Provider time requires an officer and so does the dosing with nurses. Only 1 officer available each day 8:30a-4:30p. Time constraints with increased “keep separates” does not allow more than 50 clients to be dosed per day. Inductions have slowed for this reason.

Program Changes: Hub & Spoke staff navigator being trained to monitor & respond to the kites at YCDOC daily from 2p-3p and to complete the intake paperwork from 3p-4p Monday-Friday.
