Internal referrals received from Comprehensive Healthcare Opioid Treatment Program (OTP) and Corrections Mental Health Team. All Suboxone Jail Dosing clients receive a flyer for Comprehensive Healthcare OTP for continuation of medication for opioid use disorder (MOUD) and a referral flyer for free Narcan sites. A release of information (ROI) is signed by the client for the jail/prison they will be transferring to if known. Suboxone Jail Dosing nurses coordinate with the jail/prison to assist with continuation of MOUD if the program is available at the jail/prison the client is transferring to.

3. Narrative summaries detailing program achievements/success, encountered barriers, & significant changes to the program.

**Success:** The 4<sup>th</sup> floor medical room has been designated to the Suboxone Jail Dosing team for the provider to use for client inductions, ECGs, and physical exams. Suboxone Jail Dosing nurses will be able to use this room for nursing assessments. Staff have access to Wellpath EHR to access and print medical records.

**Barriers:** Provider time requires an officer and so does the dosing with nurses. Only 1 officer available each day 8:30a-4:30p.

**Program Changes:** Workflows created & new patient inductions started offering 1 per week. Ka Chan, ARNP trained Naomi Wenzel, ARNP at YCDOC. Naomi now managing the Suboxone Jail Dosing clients at YCDOC effective October 2024.
