Rod's House Rental Assistance 2025 Contract Modification 1 (RH-RA-2025-MOD1)

Background Information:

Rod's House requested \$130,000 (per year) in the 2024-26 HHAP RFP for Rental Assistance. Rod's House was awarded \$100,000. This modification increases their year 1 award by \$30,000 bringing the total year 1 award to the full requested \$130,000 and leaving year 2 unchanged. The additional funding is from one-year non-recurring funds granted by the State Department of Commerce.




