WHEREAS, RCW 43.185C.160 requires that "Each county shall create a homeless housing task force to develop a five-year homeless housing plan addressing short-term and long-term housing for homeless persons."; **and**,

WHEREAS, the Yakima County Homeless Coalition serves as that task force in Yakima County; **and**,

WHEREAS, members of the Yakima County Homeless Coalition, as well as a broad array of stakeholders impacted by or impacting the homeless response system, were invited to a series of Strategic Sessions to develop the *2025-2029 Yakima County Five-Year Homeless Housing Strategic Plan*; **and**,

WHEREAS, there were 129 participants from across 79 unique agencies and departments who participated in the development of the *2025-2029 Yakima County Five-Year Homeless Housing Strategic Plan*, as well as dozens of community members participating in accessible, shorter, Community Engagement Sessions; **and**,

WHEREAS, The Yakima County Board of County Commissioners held a Public Hearing to discuss the *2025-2029 Yakima County Five-Year Homeless Housing Strategic Plan*, in which they determined that they would adopt the plan as presented, with the inclusion of a letter from the Yakima County Board of County Commissioners to Washington State; **now**, therefore,

BE IT HEREBY RESOLVED by the Board of Yakima County Commissioners endorses and hereby authorizes the *2025-2029 Yakima County Five-Year Homeless Housing Strategic Plan*.
